The reported result for delta-9 THC represents the quantitation of a peak that elutes in the retention time window of the delta-9 THC certified reference standard. However, it is inconclusive due to the interference of an unknown compound. LC-MS/MS analysis is recommended for a more conclusive identification and quantitation.
